BID NOTICE UNDER OPEN DOMESTIC BIDDING FOR THE PROCUREMENT OF VARIOUS NON CONSULTANCY SERVICES AND SUPPLIES.

1. The Office of the Director of Public Prosecutions has allocated funds to be used for the Procurement of various Non Consultancy Services and Supplies.
2. The Office of the Director of Public Prosecutions invites sealed bids from eligible bidders for the provision of the Non Consultancy Services and Supplies as listed below;

3. Bidding will be conducted in accordance with the *Open Domestic* bidding method contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003 and is open to all bidders.
4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8 from **8.30 am to 4.30pm**.
5. The Bidding documents in *English* may be purchased by interested bidders on the submission of a written application to the address below at 8 and upon payment of a non-refundable fee of **UGX. 100,000 (Uganda Shillings; One Hundred Thousand only)**. The method of payment will be cash payment to any bank using ODPP TIN.
6. Bids must be delivered to the address 8 below at or before **8th February 2021, at 11:00am**. All bids must be accompanied by a bid security of **UGX 2,500,000 for No.1 & No.2, UGX 7,000,000 for No.3 and UGX 3,500,000 for No.4**. Bid securities must be valid as per the SBD. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives, who choose to attend at the address below at 9 on **8th February 2021 at 11:00am**
